My main focus is in the care of cervical spine, both simple and complex. I am in the clinic one day a week at the Hospital for Special Surgery. In addition, I operate at the Hospital for Special Surgery two days a week.

There is a Spine Fellow and a Resident assigned to my service. With regard to teaching the major objectives including advancing the clinical judgment and technical skills of the fellows/ residents in the area of the evaluation and treatment of patients with spinal diseases. These disease processes including spinal deformity acquired diseases, tumors, trauma and degenerative diseases. On my spine service, I strive to provide an educational background in spine surgery, which will enable the fellow/resident to become proficient in the basic principles of spine function and in diagnosing and treating conditions of the spine. Regarding patient care, continued and ongoing improvement in the care of patients with spinal diseases is a major objective. This goal is achieved by providing a spine service that can deal with even the most complicated spine problems. Included in the goals of the surgical training is for the fellow/ resident to be exposed to multiple instrumentation systems as well as the whole spectrum of spinal procedures. Emphasis is placed on the interaction with neurology, neurosurgeons and rehabilitation specialists.
